
RK-Table Top Potter's Wheel Instruction Manual

Please read the entire instruction manual thoroughly before initial set-up and operation; the information contained herein will aid you in operating your Shimpo wheel safely and with excellent results.

Inspection/Standard Accessories

If upon delivery shipping damage is detected, do not operate the wheel. Notify shipping carrier immediately for damage claim instructions. Record serial number for future reference.

Item(s) included with the RK-Table Top are:

- (1) L-wrench
- (1) Fuse

Features and Benefits

Shimpo's compact RK-Table Top potter's wheel achieves speeds of 0-240 RPM and incorporates the following quality features:

- Compact style lets wheel fit into small spaces; stores easily
- Convenient built-in splashpan features a built-in shelf for tools and a handy drain plug
- Direction of wheel head rotation is switch-controlled, accommodating left and right hand users
- Fixed speed lever saves space and eliminates cords
- Versatile design allows use as a manual banding wheel

Important Safety Instructions



Do not plug power cord into an extension cord (plug directly into electrical wall outlet).



Do not overload the wheel head with clay or force it to stop, as this will shorten the life of the drive ring; the maximum weight of the clay should not exceed 10 pounds.



Do not turn off the motor before the speed lever is at the STOP position as damage will occur to the drive ring.



Do not move speed lever when power is off (this will damage the drive ring and cause vibration).



Do not carry the unit by the wheel head or splashpan; hold both sides of the metal housing when moving.

After operating, before cleaning or inspection:



- 1. Turn wheel OFF by adjusting the setting switch to the CENTER (OFF) position.
- 2. Unplug wheel from power source.
- 3. Do not tilt wheel to drain splashpan.

Set-Up

The following steps should be followed BEFORE operating the wheel:

- 1. Place the wheel on a firm and stable work surface.
- 2. Placing the unit on a mat can avoid vibration and noise.



Operation

Wheel Operation

- 1. Plug electrical cord into 115 volt outlet (standard U.S. household outlet).
- Select direction of wheel head by adjusting the setting switch: in the REV. position, the wheel will turn counterclockwise; in the FWD. position, the wheel will turn clockwise; in the CENTER (OFF) position, the wheel is stopped (figure 1).

CAUTION: Do not quickly change the direction of the wheel head. Before switching the direction, set the switch to the CENTER (OFF) position. Wait at least 5 seconds until the motor stops completely then set the switch to the new direction desired.

3. Place clay on wheel head.


CAUTION: Do not overload the wheel head with clay; the maximum weight of the clay should not exceed 10 pounds.

- 4. Move speed lever forward to desired speed (figure 2); move lever backward to reduce speed.
- 5. To stop the wheel, move the speed lever to the STOP position.
- 6. To turn off the wheel, move the setting switch to the CENTER (OFF) position.

CAUTION: Do not turn off the motor before the speed lever is at the STOP position, as damage will occur to the drive ring; do not move speed lever when power is off.


Banding Wheel Operation

The wheel head can be used as a manual banding wheel when the speed lever is at the STOP position and setting switch is at the CENTER (OFF) position. Turn the wheel head by hand in either direction when desired.

Maintenance

With proper operation and care your Shimpo RK-Table Top wheel will last for many years.

The wheel head and splashpan should be thoroughly cleaned after every use to prevent water, clay or slip from entering the unit's housing, potentially causing corrosion and damage to the wheel:

- 1. Turn motor OFF by adjusting the setting switch to the CENTER (OFF) position.
- 2. Unplug wheel from power source.
- 3. Remove the rubber plug from the drain hole in the front of the splashpan.
- 4. With a sponge or towel, remove all water and clay slurry from the pan, wheel head and cabinet.
- 5. Replace plug in splashpan.

CAUTION: Do not tilt wheel to drain splashpan.

Repair/Replacement

Speed Lever Brake Adjustment

The brake adjustment for the speed lever may need to be adjusted as necessary:

- 1. Turn wheel OFF by adjusting the setting switch to the CENTER (OFF) position.
- 2. Unplug wheel from power source.
- 3. Loosen nut with an adjustable wrench (figure 3).
- 4. To tighten the brake, turn bolt on opposite side of nut clockwise 1/4 turn.
- 5. Retighten the nut to lock.
- 6. Test and readjust as necessary.

Fuse Replacement

- Turn wheel OFF by adjusting the setting switch to the CENTER (OFF) position.
- 2. Unplug wheel from power source.
- 3. Insert flat head screwdriver into slot on fuse cap and unscrew (figure 4).
- 4. Remove fuse.
- 5. Replace with spare fuse from original shipment or use a 3AG, 10 AMP, 125V fuse.
- 6. Replace fuse cap.

Drive Ring Replacement

- 1. Turn wheel OFF by adjusting the setting switch to the CENTER (OFF) position.
- 2. Unplug wheel from power source.
- 3. Place potter's wheel on side.
- Insert L-wrench (provided) and remove bolt on bottom of wheel shaft (figure 5).
- 5. Remove wheel head from top of unit.
- 6. Place wheel head upside down.
- 7. Push screwdriver through hole on the side of the wheel head to remove drive ring from groove (figure 6).
- 8. Place new ring into position.
- 9. If part of the ring remains out of the groove, apply pressure along the entire ring until it is properly seated (figure 7).
- 10. Return wheel head to original position.
- 11. Replace washers and bolt on base of wheel shaft and tighten.
- 12. Return to upright position.



Troubleshooting

The wheel has either stopped or does not turn on:

Confirm that all electrical components are functioning properly (power source, power cord and fuse)

The wheel experiences a drop in power:

- Confirm that all electrical components are functioning properly (power source, power cord and fuse)
- The drive ring may require replacement (refer to DRIVE RING REPLACEMENT section of manual)


The speed lever moves on its own during throwing:

• The speed lever brake may need to be adjusted (refer to SPEED LEVER BRAKE ADJUSTMENT section of manual)

The wheel does not stop rotating when speed lever is set to STOP:

· The wheel head will continue to rotate momentarily until the inertia is dissipated

Shimpo reserves the right to satisfy warranty obligation in full by reimbursing Buyer for all payments made to Shimpo, whereupon, title shall pass to Shimpo upon acceptance of return goods.
